ANNEXURE "A"

1. The contractual appointees will be eligible for regularization against the available vacancies.
2. The Regularization will be strictly on the basis of seniority subject to the conditions that eligibility criteria etc, prescribed in the Recruitment and Promotion Rules for the post have been observed at time of their initial recruitment on contract.
3. The Candidate should be medically fit for the post against which He/She being considered for regularization. Obtaining the Medical fitness certificate of the candidate shall be ensured in accordance with the provision contained in FR-10, SR-4 (1) (2) & 4 (3).
4. The regularization shall be subject to verification of character and antecedents of the candidate being considered for the regularization as provided in the financial rules.
5. For the determination of Date of Birth of the candidate concerned criteria as laid down in the rule 7. 1 of the HPFR vol. 1 handbook No.2 shall be observed.
6. The contractual appointee who is to be regularized shall be put in the minimum of the time scale of the post.
7. The contractual so regularized shall be liable to be posted in anywhere in the State.
8. The regularization shall be subject to orders regarding reservation in the service for the SC/ST/OBC/ other categories of persons issued by the H.P. Govt. from time to time.
9. He/ she shall have to produce attested copies of Matriculation/ other qualification certificates / certificate belonging to SC/ST/OBC etc.
10. He/ she shall have to produce certificate of bonafide certificate issued by the competent authority.
11. He/ she shall have to furnish declaration to the effect that the appointment may be terminated any time by the undersigned without any reason, if his/her certificates/ documents found fake/ false at the later stage.
12. He/ she shall have to take an oath of allegiance on behalf of Constitution of India.
13. He/ she will have to give in writing an affidavit that he/ she is not convicted as criminal by the criminal Court and if convicted show the particular of offence and punishment imposed. If failure to disclose the facts will rendered her removal from service without any notice as soon as factual position come in light /notice.
14. He/ she shall have to give in writing in affidavit that he/ she has not registered with any other exchange in H.P.
15. The regularization will be with prospective effect i.e. from the date of issue of regularization orders.
16. The orders of regularization have no relation with seniority.
17. The regularization of the said teachers as per amendment dated 09.08.2017 of RTE act 2009, failing which their increment and financial benefit will be stopped.
